The Vaultler, Participant, and/or the parent/guardians of the minor children, HEREBY COVENANTS AND AGREES that neither the MCVC and/or Creekside Equestrian Centre Ltd. coaches, lungers, members, directors, their heirs, successors, assigns or employees, or any of them, individually or collectively, will be responsible for any accident that may occur or be caused by any horse, rider, vaulter or other person, animal or equipment, or for any article of any kind or nature that may be lost or destroyed or in any way damaged. Each person using the premises, and/or the services of the MCVC and/or Creekside Equestrian Centre Ltd. off the premises will be responsible for any injury that may be occasioned to any person or animal or for any damage to any property.
